

## APPENDIX V

### *Concordance of early press marks*

On these early press marks, see *Introduction*, pp. 54–57. The arrangement of the presses suggests a fairly logical sequence of subject matter, beginning with works relating to the study of the Bible, particularly commentaries (Cases A–D), then Theology (from Case E onwards), with a particularly large collection relating to contemporary Reformation controversies. Cases R–T contain items of more miscellaneous subject matter.
